# **INTRODUCTIONS:**

Chrissie, welcomed the group at 10:05. Introductions took place. Minutes were reviewed with one correction. There was a motion to approve and a second motion to approve. Coalition members present, approved.

#### I. **GUEST PRESENTER:**

Kathleen Moore and Bailey Thompson, from the University of South Florida, presented their evaluation results from the pediatric primary care and behavioral health integration program. After presenting the results, the presenters provided suggestions for the community. A short discussion followed.

#### II. **PROBLEM ANALYSIS:**

Chrissie and Monica led a conversation on drug priorities in Pasco County. Present members brainstormed which drugs posed the greatest threat to Pasco. Marijuana, alcohol, and tobacco were ranked highest. Other drugs, such over the counter triple Cs, caffeine, prescription drugs, and synthetic drugs, were also mentioned. Monica made the point that it is good that the coalition was not completely united on a main drug issue, because that means the coalition is properly preventing the drug crises we witnessed in the past. Another discussion began on how to take the coalition to the next steps in the transition from reactive measures to proactive measures.

# IV. MARIJUANA TASK FORCE:

Mykenzie shared feedback from Tampa Bay Drug Summit 2014 Day One on marijuana information and issues that resounded with her and the teen population. Shelah provided update on tracking of community knowledge and perception survey and the youth access survey. Shelah facilitated discussion on topics for community presentations with key focus on "Ah-Ha Moments" surrounding marijuana education.

# VI. ALCOHOL INITIATIVES:

The committee has set the regular time for the third Wednesday of every month at 3:30pm. Melissa Giles and Sabel Taylor have agreed to co-chair. The group shared potential themes and hashtags for the upcoming social marketing campaign for Saint Patrick's Day. Coasters with options for sober rides home, including the AAA Tow To Go program will provided to many bars, including the top named bars from the last drink survey. The group has also identified initiatives related to Boating While Intoxicated and underage drinking on the local sandbars. Discussion ensued about unique ways to get messages out in bars and bathrooms.

# VII. EVENTS COMMITTEE:

Paula Green has stepped up to chair the ASAP's events committee. This committee was formed to gather information on community health fairs and events that ASAP would want to participate in.
