Lt. Charles Balderstone was honored by A.S.A.P. and thanked for his instrumental involvement with A.S.A.P. and for what he has done for the community. He is retiring from the Pasco Sheriff's Office in September.

II. Guest Speaker: Matthew Dunagan, Attorney General's Office

III. <u>Prescription Drug Committee:</u>

A. Medication Checklist

Committee has designed a medication checklist for individuals in community. It has been approved by Morton Plant North Bay to be used in the month of September to gather baseline data. The goal is to distribute the check list as a tool for discharge nurses and to build a community wide education program on prescription drug safety.

Alan spoke on pill drop at Morton Plant North Bay Hospital from 9 - 12pm on August 17th. It was very successful, garnishing one hundred and sixty seven pounds of pills plus sharps. The permanent pill drop sites have brought in hundreds of pounds a year.

B. E-Force

Chris Whittman has been a strong force on this initiative. Chrissie shared that we are moving forward in trying to engage medical professionals and to sign up for E-FORCSE. E-FORCSE is Florida's Prescription Drug Monitoring Program. ASAP would like to support and acknowledge practitioners in Pasco County helping to address pain in through responsible practices. E-FORCSE participation can possibly used as a tool for the coalition to support these practices. To participate in these conversations, attend a prescription drug committee meeting the first Wednesday of the month. All meetings are listed on the back of the agenda.

IV. <u>SEN'S Committee:</u>

A. OB presentations:

SEN distributed and gathered information from a follow-up survey for already trained practices. Twenty-five percent are actively screening. Liana shared Gabby had a baby girl, Nicole.

B. Public Service Announcements:

Chrissie showed the PSA's created by A.S.A.P. to strengthen the norm that it is not safe or legal to share prescription medications. All spots can be found online at present in eventual hope is to eventually get them on television. Cox Media will do radio PSA's for us for free.
